

**PLANNING COMMISSION
MINUTES
AUGUST 24th, 2021**

The regular meeting of the Planning Commission of Westover Alabama was held in the City Hall in Westover, Alabama August 24th, 2021, at the appointed place for such regular sessions.

The meeting was called to order at 6:30 p.m.

ROLL CALL

READING AND APPROVAL OF THE MINUTES:

The minutes of July 27th, 2021 meeting were presented for adoption.

A motion was made by Commissioner Wiggins to disperse with reading and to adopt the July 27th, 2021 minutes of Planning Commission Meeting as presented.

A second was made by Mayor Riggins

Commissioner Floyd stated that she would like the minutes of July 27th, 2021 meeting read.

Secretary Manning read the minutes of July 27th, 2021 meeting in their entirety.
